OFFICIAL RULES**

1. PROMOTION DESCRIPTION: The "Fox Sports Net Detroit Belle Tire Power Play" (the "**Sweepstakes**") is sponsored by Fox Sport Net Detroit, LLC, 26555 Evergreen Road, Suite 90, Southfield, Michigan 48076, and Belle Tire, 1000 Enterprise Drive, Allen Park, Michigan 48101 (each a "Sponsor" collectively, the "Sponsors"). The Sweepstakes consists of six (6) independent prize sweepstakes (each, a "Prize Sweepstakes") to win admission for four (4) to a professional hockey game during the 2009-2010 hockey season (as set forth in rule #6 hereinbelow). See chart as set forth in rule #3 for specific Prize Sweepstakes "Registration Periods" (as defined below). The Sweepstakes begins on or about October 8, 2009, at 9:00:01 a.m. Eastern Time ("ET") and ends on April 10, 2010 at 8:59:59 p.m. ET (such entire period of time referred to hereinafter as the "**Sweepstakes Period**"). Entry into one Prize Sweepstakes does not constitute entry into any other Prize Sweepstakes, promotion, contest or sweepstakes. By participating in the Sweepstakes, each entrant unconditionally agrees to abide by these Official Rules and the decisions of Sponsors, which shall be final and binding in all matters relating to this Sweepstakes.

2. ELIGIBILITY: The Sweepstakes is open only to legal residents of the State of Michigan who are eighteen (18) years of age or older at the time of entry. Void where prohibited by law. 4. HOW TO ENTER: No purchase necessary to enter or win. Making a purchase will not improve your chances of winning. DURING EACH PRIZE SWEEPSTAKES, EACH ENTRANT SHALL HAVE THE OPPORTUNITY TO SUBMIT THE NAMES OF THE POWER PLAY GOAL SCORER DURING A POWER PLAY AT THE CORRESPONDING HOCKEY GAME REGARDLESS OF METHOD OF ENTRY. PARTICIPATION IN THE PLAYER IDENTIFICATION PORTION OF THE PROMOTION IS FOR ENTERTAINMENT PURPOSES ONLY AND ACCURATE IDENTIFICATION OF THE PLAYER IS NOT REQUIRED FOR ENTRY INTO EACH PRIZE SWEEPSTAKES. Each online entry must provide a valid e-mail address to be eligible. In the event of a dispute regarding the identity of who actually submitted an entry on the Website, the entry will be deemed submitted by the authorized account holder of the e-mail address supplied at the time of entry. An "authorized account holder" is defined as the natural person to whom the applicable e-mail address has been assigned by the internet access provider, on-line service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the address submitted. The potential prizewinners may be required to provide Sponsor with proof that he/she is the authorized account holder of the e-mail address associated with the winning entry.
